The Johnson County School District No. 0050 Board of Education met in regular session at 6:30 p.m. on Wednesday June 10, 2020, in the cafeteria in Tecumseh Nebraska. A current copy of the agenda was available for inspection in the office of the Superintendent prior to the meeting. The notice of meeting being streamed via STRIV and the agenda was posted at the three main school buildings as well as the Tecumseh and Cook Post Offices. President, Kim Wellensiek called the meeting to order at 6:35 p.m. by announcing that the Open Meetings Act rules were posted.
