The Johnson County School District No. 0050 Board of Education met in a special session Wednesday, June 14, 2023, at 7:00 p.m. in the Elementary Auditorium, Tecumseh, NE. A current copy of the agenda was available for inspection in the office of the Superintendent prior to the meeting. The notice of meeting and agenda were posted at the three main school buildings as well as the Tecumseh and Cook Post Offices. Notice of the meeting was also published in the Tecumseh Chieftain.

President, Kim Wellensiek called the meeting to order at 7:02 p.m. and opened the meeting by announcing that the Open Meetings Act Rules were posted. Roll call was taken. Arlin Beethe-present, Justin Beethe-present, Bob Hutt-absent, Gail Hutt-present, Plager-present, Wellensiek-present.

President Wellensiek thanked everyone for attending. The meeting was then turned over to Superintendent, Jon H. Rother.

SUPERINTENDENT PRESENTATION

Superintendent Rother introduced the team working on the proposed building project. Those present were members of Clark & Enersen (Architect Firm) Jeff Chadwick, Steve Miller, Tim Ripp, Boyd Jones (Construction Manager at Risk) Leila Knowles and DA Davidson (Bond Underwriter) Cody Wickham. Mr. Rother provided background information as to why the Board of Education started looking at such a building construction project. Work the team has completed to assist the Board of Education in their decision to hold a Building Bond Election requesting not more than \$49,500,000 was provided. The bond request is for the purpose of paying the cost of land acquisition and construction and acquisition of a Pre-K to 12th-grade facility and providing for the necessary furniture, equipment and apparatus for such facilities.

Mr. Rother shared and explained the current conceptual plans for the PreK-12th grade building project. These plans are still in the development stage, Tax impact information in regards to the proposed bond and what it would mean for stakeholders of the district was provided. Superintendent Rother informed the patrons how to estimate the tax impact and offered additional opportunities for district stakeholders to get assistance with understanding the tax impact on their personal property.

Superintendent Rother provided historical bond and building data as well as the projected savings from being at one site. Enrollment information was provided. The bond election is scheduled for July 11, 2023 and is a mail-in election.

Throughout the presentation, the floor was open for additional public comments and questions. Questions were answered. On behalf of the Johnson County Central Board of Education, President Kim Wellensiek thanked everyone for attending the meeting.

A motion to adjourn the meeting was made by Arlin Beethe and second by Rebecca Plager. Roll Call vote: Arlin Beethe-yes, Justin Beethe-yes, Bob Hutt-absent, Gail Hutt-yes, Plager-yes, Wellensiek-yes. Carried 5-0.

Meeting adjourned at 8:34 p.m.
