“STOP-IT” CLASS

WHAT IS THE STOP-IT PROGRAM?

Stop-it (Smart Topics On Personal iPad Technology) is a mandatory course offered by JCC School to students who have violated the Policies and Procedures for iPad Handbook. The iPad handbook is signed annually by both parents and students before the student is allowed to use school technology resources. The Stop-it program has been designed and implemented by the school to provide additional instruction for users who have demonstrated the need for further training in the area of responsible student use of online and iPad resources.

WHAT HAPPENS IF THE STUDENT VIOLATES THE iPad HANDBOOK?

If a student violates the JCC School iPad handbook, the student will lose their iPad privileges for a period of time to be determined by the high school principal. Before the iPad will be returned to the student, a Stop-it agreement must be signed by both the parent and student and returned to the principal. In signing the Stop-it agreement, the student agrees to attend the next available Stop-it class. This class will be scheduled one Wednesday per month from 3:45 p.m. to 4:30 p.m.

WHAT ARE THE BENEFITS OF THIS CLASS?

By participating in the class, the student will participate in activities and lessons about Digital Citizenship and responsible use of online and iPad resources. Digital citizenship lessons help students learn how to be smart and effective participants in a digital world. That means helping them understand their rights and responsibilities, recognize the benefits and risks, and realize the personal and ethical implications of their actions.

WHAT HAPPENS IF THE STUDENT DOES NOT ATTEND THE SCHEDULED STOP-IT CLASS?

If a student fails to attend the scheduled Stop-it class, they will lose take-home privileges for their iPad until such time as they attend a Stop-it class. Habitual violations may result in the complete loss of school technology privileges altogether, for a time-period to be determined by the principal.

STUDENT AGREEMENT TO PARTICIPATE IN STOP-IT PROGRAM

Due to violations of the iPad handbook the student has been enrolled in the Stop-it program. This program has been designed and implemented by the school to provide additional instruction for users who have demonstrated the need for further training in the area of responsible student use of online and iPad resources.

Successful completion of this program is one of the requirements for school technology take-home privileges to be restored to the student. Other requirements are at the discretion of the principal.

The student agrees to attend and fully participate in the Stop-it course, and agrees to complete all required course assignments as assigned by the course instructor.

Further violations will require repeating the course and meeting all obligations therein assigned, as well as but not limited to the possible loss of all take-home and in-school technology use privileges for the duration of the school year. Such conditions will remain at the discretion of the principal.
