# AQuESTT - GREAT!

Based on the spring of 2024 state assessment data, the Johnson County Central school district earned a "Great" rating!

Accountability for a Quality Education System, Today and Tomorrow (AQuESTT) is Nebraska's "accountability system that supports and rewards continuous improvement for every student, school, and educator." Using student test scores from the NSCAS (Nebraska Student-Centered Assessment System) and ACT, the Nebraska Department of Education gives each school, and each school district, a designation. NSCAS is administered to students in grades 3-8 in the areas of English-Language Arts and Math. NSCAS Science is administered only to grades 5 and 8. The ACT Language Arts, Math and Science is administered to students in 11th grade.

Once test scores are collected, the State then uses these scores to determine each school's status. This is done on a point scale of 1 to 4 with 4 being the highest score.

After this, they use the following tenets to adjust the score:

- Participation (percent of eligible students participating in the assessments)
- Positive Partnerships, Relationships and Success
- Transitions
- Educational Opportunities and Access
- Postsecondary, Career and Civic Ready
- Student Achievement and Growth
- Educator Effectiveness

Once adjustments are made using the seven tenets, the scores are then transferred to a classification based on the final number.

4 = EXCELLENT

3 = GREAT

2 = Good

1 = Needs Support To Improve

# What's a QCPUF?

Johnson County Central currently levies  $3\phi$  (or approximately \$273,000) through the QCPUF. Here is the definition as provided by The Nebraska Department of Education, Rule 2, Uniform System of Accounting for Nebraska Public School Districts:

A Qualified Capital Purpose Undertaking Fund (QCPUF) may be established for the removal of environmental hazards, the reduction or elimination of accessibility barriers in school district buildings, the repayment of a qualified zone academy bond issued for a qualified capital purpose, modifications for life safety code violations, life safety hazards, and mold abatement and prevention projects for existing facilities only.

A 2023 School Board Building Committee review of the facilities identified the following as priorities for the existing buildings:

Tecumseh Site Elementary

- Exterior/Interior Doors and Entries
- Heating, Ventilation and Air Conditioning (HVAC)
- Water Lines
- LED Lighting
- Fire Sprinkler System

# High School

- Heating, Ventilation and Air Conditioning (HVAC)
- Concrete Walkway Replacement & Repair
- Secure Entries
- Fire Sprinkler System

# Cook Site Middle School/Elementary

- Heating, Ventilation and Air Conditioning (HVAC)
- Kitchen Remodel
- Roof Repair/Replacement
- LED Lighting

As these issues have been identified, and would qualify under QCPUF, funds from this account can now be used to address them.

# The Johnson County/Foodbank of Lincoln Backpack Program

Currently, JCC distributes 63 food "backpacks" to families in the district as part of the Foodbank of Lincoln's Backpack Program. The backpacks come at a cost of \$275 per student for the school year. In order to maintain providing this resource to food insecure students, fundraising efforts must be done.

As part of Johnson County Central's commitment to students' safety and mental health, beginning in November 2024 we are launching an anonymous reporting program, which will allow students and parents to make anonymous reports about concerns of safety or student wellness. Our program is student-focused, as opposed to crime-focused, meaning it is a tool for alerting caring adults about students who need help—not snitching. This is part of our continuous effort to increase campus and student safety, and provide students with a safe, completely anonymous outlet to share concerns. Students can use our new Safe2HelpNE app to report: bullying, suicide concerns, depression, sexting, stealing, threats, cutting, abuse, dating and domestic violence, fights, drugs, alcohol, weapons or other types of dangerous situations that threaten their safety or the safety of others. Their reports will be addressed by a trained school threat assessment team.

When you or your student have a concern, you can go to www.safe2helpne.org on your computer, tablet, or laptop-- or you can download the free Safe2HelpNE mobile app-- and make a 100% anonymous report in less than five minutes.

The use of anonymous reporting apps in state programs like Safe2Tell Colorado have proven to be successful in providing the tools and information needed for school officials and to proactively address concerning behaviors, potential incidents of violence, and other harmful situations on campus before they develop. We look forward to working with you and your student to continue making Johnson County Central a safe school.

## **Identity Protection and Credit Monitoring Services:**

PowerSchool has announced that they have engaged Experian, a trusted credit reporting agency, to offer complimentary identity protection and credit monitoring services to all students and educators whose information from our PowerSchool SIS was involved. This offer is being provided regardless of whether an individual's Social Security number was exfiltrated.

**Identity Protection**: PowerSchool will be offering two years of complimentary identity protection services for all students and educators whose information was involved.


Credit Monitoring: PowerSchool will also be offering two years of complimentary credit monitoring services for all adult students and educators whose information was involved.

**Notifications**: Starting in the next few weeks, Power School will be handling notifications to involved individuals. Power School will coordinate with Experian to provide notice to students (or their parents / guardians if the student is under 18) and educators, as applicable, whose information was involved, as well as a call center to answer questions from the community. The notice will include the identity protection and credit monitoring services offer (as applicable)

# Kindergarten Round-Up



WHEN: Monday, April 14, 2025

9:00-11:00 a.m.

WHERE: Johnson County Central Elementary Building in Tecumseh.

WHO: Children residing in the Johnson County Central school district who are, or will be, age 5 on or before July 31, 2025.

Individual letters will be sent in April to the parents of all Kindergarten ready students residing in Johnson County Central's school district. If you do not receive a letter, please call the school and let us know that you will be attending the 2025 Kindergarten Round-Up.

If applying for early registration (child will be 5 years old on or after August 1 and on or before October 15), JCC must have received your written request by March 13, 2025.

# **NEWS FROM PRINCIPAL RICK LESTER**

The month of February is our first step in preparation for next fall where our students will start pre-registration for the 2025-2026 school year.

What is pre-registration? The students choose their top eight classes and two options - at this time there is no set schedule. Once all pre-registrations are complete we'll plan the class schedule. Every student must sign their pre-registration form and their parents must also sign off on it. Mrs. Reuter, the school counselor, is the final signature on every student's pre-registration form. She reviews each student's class selection to verify they are taking appropriate classes which are required for each grade and are meeting their graduation requirements.

Students will receive their pre-registration forms on Wednesday, February 5, 2025. They will be due back to the office on Thursday, March 13, 2025. This due date is necessary so that we can plan the class schedule. We try to create a schedule that accommodates the most students with the least amount of conflicts. Once we have the best class schedule created, Mrs. Reuter will personally meet with each student who has a class conflict. A student will only have a class schedule conflict if they are unable to get an eight period class schedule by using their eight selected classes or two options. Mrs. Reuter will then aid them in selecting an additional alternate class until we are able to fill their eight periods with an appropriate schedule.

After we have completed a successful class schedule, we will send out summer pre-registration letters to all students. Around the first week in August, each student will receive this letter which will contain their actual class schedule, complete with periods and teachers for every class. If the students and parents are satisfied with this schedule, nothing more needs to be done before the beginning of school next fall. If students desire to make changes to their class schedule they will have a scheduled day (to be announced), to meet with the counselor to make changes prior to the start of school. Students will also have the first five days of the 2025-2026 school year to change their class schedule.

I encourage all parents to work with your students to help them plan their 2025-2026 class schedule - your input and encouragement is essential.

# Johnson County Central Foundation Scholarship Applications- Due March 21st

The Johnson County Central Foundation is offering nine scholarships to JCC seniors this year. To apply, seniors must fill out the application that was emailed to them. Seniors will need to follow the instructions on the application and also have two references, one from someone in the school, and one from someone outside the school (an employer, community member, church pastor, etc.) There will be three \$2000 four-year college/university scholarships awarded, three \$1000 two-year college scholarships available, and three \$1000 trade school scholarships awarded. All scholarship applications must be given to Mrs. Reuter by March 21<sup>st</sup>.

# Nebraska's New Universal FAFSA Requirement- All Seniors in the Class of 2025 Must Fill Out the FAFSA

Nebraska law now requires all public high school students to complete and submit a FAFSA (or actively opt-out) as a graduation requirement starting with the graduating class of 2025. This type of requirement is also referred to as a Universal FAFSA requirement. FAFSA became a graduation requirement with the passage of revised statute 79-729 in 2023. This legislation applies to seniors who will graduate in 2025 and beyond.

The Nebraska legislature determined that the FAFSA is an excellent opportunity to learn of financial aid they may receive, to encourage postsecondary education, and to make more informed college-going decisions. There are many resources to complete the FAFSA. If students need help, they can definitely ask Mrs. Reuter. Filling out the FAFSA does not mean that students must make the ultimate decision of going to college. The FAFSA just allows them to see what financial resources are available to them if they decide to go to college.

If students and their parents decide that filling out the FAFSA is not right for them, for any reason, there is a waiver form available in both English and Spanish. Students who do not fill out the FAFSA must complete a waiver form with their parents and turn it into Mrs. Reuter by May 1st.

# JCC Preschool Enrollment for the 2025-26 School Year Opens February 1, 2025

Dear Family,

We know you are your child's first and most important teacher, and we would love to join you in the education of your young learner. The purpose of the Johnson County Central Preschool Program is to promote the social, emotional, intellectual, language, physical, and aesthetic development and learning for the children served and to promote family development and support. The preschool schedule encompasses discovery through active involvement. Activities, materials, and equipment reflect and respect the diversity of race and multiculturalism and the physical and mental abilities of all children. It is preferred that your child be fully toilet trained before entering the program.

The program will be available to children of the following ages:

- Children who are 3 years of age on or before July 31 of the enrollment year;
- Children who are 4 years of age (on or before July 31 of the enrollment year) at the start of the enrollment year; and
- Children who are 5 years of age at the start of the enrollment year, so long as they do not turn 6 years of age prior to January 1 of that year (subject to the participation limitation below).

All enrollment is subject to capacity limitations and established enrollment priorities. Three-year-old children will only be offered half-day attendance. Four-year-old children will be offered full-day or half-day attendance. The full-day option will be filled on a first come, first served basis.

Five-Year-Old Participation - Participation of 5-year-old students who will not turn 6 prior to January 1 of the enrollment year will be further limited to those students who have met the score criteria per district policy on the Brigance Early Childhood Screen III (3–5 years).

All preschool programming will be housed at the Tecumseh site. Transportation will be provided to and from licensed child care providers at no cost. Who: Students in grades PK-6 Where: JCC's Tecumseh Site

When: 4:15 PM-6:15 PM each day school is in session

JCC will once again provide an after school program. The program is for students in preschool through the 6th grades. The intent of the program is to provide quality services to students as their caregivers make the transition from work to home. Students will be provided with homework assistance, learning opportunities and engaging activities. Mrs. Amber Baehr is the After School Program Coordinator and will serve to organize activities and programming for the students.

Tuition for the program is set at the following:

- \$25 per week for 4-year-old preschool students through 6th grade students.
- \$20 per week for 3-year-old preschool students.
- Each additional sibling will be \$15 per week.

Transportation to the after school program will be provided for students coming from the Cook Site. However, parents/guardians will be required to provide transportation for their child at the conclusion of the program each day.

To register your child for the after school program, simply contact the school office and submit your tuition payment.
